

TEXTILE DISCOVERY SUMMIT 2024 EXHIBIT OVERVIEW

The 2024 Textile Discovery Summit will be held at The Westin Savannah Harbor in Savannah, GA, October 6-8. Exhibitors may choose between the Royal or Classic Package. Each option will provide exhibitors with an 8' x 30" draped table. Details for each package can be found on [AATCC.org](https://www.aatcc.org). Exhibits will be set up in Grand Ballroom C at the Westin.

Tabletop Displays:

Items should be displayed on the top of the 8' x 30" table; backdrops are allowable if on a stand and flush with the wall with the 8' table in front of it.

The Royal Package includes display floorspace for a total of 14 ft. including 8 ft. table; floorspace plans must be submitted for approval to Matt Brennan, brennanm@aatcc.org, by September 6, 2024. Items must be no higher than 4' above the table.

TERMS AND CONDITIONS

The Royal Package rental fee for each 8' x 30" table is US\$3,650 per table for AATCC Corporate Members (US\$6,050 for non-members). The Classic Package rental fee for each 8' x 30" table is US\$1,500 per table for AATCC Corporate Members (US\$2,075 for non-members). Full payment of the rental fee must accompany the request for a tabletop.

- 1) No refunds will be made after August 25, 2024. Payment may be made by check, MasterCard, VISA, or American Express.
- 2) International Exhibitors: If paying by check, it should be a cashier's check drawn on a U.S. bank in U.S. funds. If payment is to be made by bank transfer, a wire transfer application must be requested and completed in its entirety and submitted to AATCC. A service fee of US\$30.00 will be charged for a bank transfer and should be included in the amount of the wire transfer.
